1. Gurans Rural Municipality Office has allocated funds towards the cost of following projects and intends to apply part of the funds to cover eligible payments under the Contract for following projects. Bidding is open to all eligible Nepalese Bidders.
2. Gurans Rural Municipality Office invites electronic bids from eligible bidders for the following projects under National Competitive Bidding procedures.
3. Eligible Bidders may obtain further information at the Gurans Rural Municipality, Ranimatta, Dailekh Phone N0: 9858020144 & PPMO website.
4. Bid must be submitted by epp system from pppo website before 12:00 PM on 31st day (2081/06/29) of Publication. Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 PM on 31st day (2081/06/29) at the Gurans Rural Municipality Office. If the bidder's representative does not choose to attend for opening, there will be no objection in opening the tender.
6. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security amounting to a minimum of 2.5% of estimated amount, which shall be valid for 30 days beyond the validity period of the bid. If the bidder wishes to submit the bid security in the form of cash, the amount should be deposited in Prabhu Bank Ltd., Ranimatta Branch, Account Name: Gurans Rural Municipality, Dailekh, Dharauti Khata, and Account Number: 1550109299100071 or bank guarantee. And bid document fee must be deposited in Prabhu Bank Ltd. Ranimatta Branch, Rajaswa Khata, and Account No. 1550109299100081.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
